#### **Privilege of the Floor:**

Before opening Privilege of the Floor, the president reported that the Board had just received a letter from owner John Zollo dated May 21, 2020. Mr. Zollo alleges that the ALHA Board of Directors is acting illegally in connection with the Harbor Restoration Project and related assessments and claims that he is exempt from paying those assessments. He closes by stating that he will sue the Board if the Board continues with the project.

The president indicated that during Privilege of the Floor, beyond the Harbor Restoration Update Report already presented, the Board would not be able to answer further questions as there hadn't been opportunity to share the threatening letter with ALHA's D&O insurer.

One question was asked; please see the attached communication.

Mr. Zollo asked several unrelated questions about the right of way docks which the Board promised to look into.

 A question was raised by a homeowner concerning renewal of ALHA's dock permit (expires June 19, 2023). This renewal date will be noted on ALHA Meeting Agendas going forward. A maintenance dredging of the boat channel is also permitted through 2023.
